Maryellen Canuel made the motion to hire both individuals for up to 19 hours per week with the caveats; that the board reserves the right to review the financials each month of the 6 month probation period and if they assess that the financials are not sufficient then they can make the necessary cuts or changes to the schedule accordingly, they are training with existing trainers that are deemed reliable trainers by Dale Barton, and in the event that a driver is available then that driver is to be given the shift so that the trainees can be in the back of the ambulance learning, if a driver is not available then the medic or trainee on duty will drive the ambulance, depending on the medical needs of the patient.
