# Resolution - Revisions to EMS billing rates

WHEREAS, The Village of New Berlin has reviewed certain fees billed by the New Berlin Ambulance Service, and

Whereas, the last time billing rates have been adjusted was in 2017, and

WHEREAS, the board has identified certain fees that do not meet the area benchmarks with other ambulance services in the area and for greater consistency of fees charged, and

NOW, THEREFORE, be it

RESOLVED, That the Village of New Berlin hereby sets the billable rate for those items as follows:

- 1. Billable Mileage rate increase from \$25/mile to \$36/mile.
- 2. BLS billable rate for medic's rate increase from \$1,081 per call to \$1,500 per call.
- 3. ALS billable rate for medic's rate from \$1,331 per call to \$1,900 per call.

This resolution shall take effect immediately and shall apply to charges billed on June 1, 2024 forward, until such time as a resolution replaces the rates approved in this resolution.
